Throughout 2013 we had the profound honor of immersing ourselves in the 30 year legacy of Simpson Housing Services. As we engaged in a deep strategic planning process, we had the opportunity to hear from all varieties of community partners and stakeholders in our work.

What initially emerged from this process was a very clear foundation upon which our successful work has been built, for today and for the future. The essence of this foundation is solidarity with all members of our community and a firm belief that everyone has a right to safe and sustainable housing.

Building from that foundation, we have established a clear path for our work over the next five years. This work will remain true to our legacy and will guide the utilization of our resources in a way that yields the most substantial impact on our community.

First, we are seeking to end generational homelessness and poverty for the families in our programs by expanding our educational support programming to reach all of the youth and children within those families, from birth through 18 years of age. Working with parents to best utilize public education systems and building life skills in young adults will ultimately strengthen our communities.

Second, we are striving to improve the mental and chemical health of all of our program participants. This will be achieved through a mix of internal resources and expanding collaborations with partner agencies. Ultimately, partnering with our program participants to overcome these barriers will lead to greater self sufficiency, family stability and housing stability.

Finally, we are introducing a more holistic approach to service delivery which will allow participants in all of our programs to access the best features that each program has to offer.

As you will see from this report, 2013 was an excellent year in terms of service delivery and improved outcomes for our participants. Building on our strengths, and working alongside all of you - there is tremendous promise for deeper impact in the years to come.

OUR MISSION

FAMILIES AND CHILDREN

FAMILY SUPPORTIVE HOUSING

Our family housing programs offer affordable housing and comprehensive support services for families experiencing homelessness. We are committed to serving families that face multiple barriers to housing such as: institutionalized racism, generational poverty, mental illness, and chemical dependency.

EDUCATION & EARLY CHILDHOOD SUPPORT

Families in our supportive housing programs have access to early childhood services and educational support (Soar) to help end the generational cycle of poverty and homelessness. Parents with children ages 0-5 can receive developmental screenings and in-home services to encourage positive growth and development. Elementary-aged children who are behind in school work one-on-one with staff and volunteers to enhance their academic success.

SINGLE ADULT HOUSING

WOMEN'S HOUSING PARTNERSHIP & SARA



Our single adult housing programs work with long-term homeless men and women who have significant barriers to housing stability and who have been frequent guests in local shelters. We place each

individual in a safe, affordable apartment and provide ongoing support services that encourage independence and overall wellbeing. In 2013, the average age of program participants was 46 years old. 92% of men and women in our single adult supportive housing programs have a mental illness and 74% deal with chemical use or addiction.

OPPORTUNITY HOUSING PARTNERSHIP

In 2013 Simpson Housing Services partnered with Aeon and Spectrum Mental Health to provide support for long-term homeless single adults living at Aeon's Lamoreaux and Continental apartment buildings in downtown Minneapolis. Simpson employs a program manager, two case managers, and a resident connections coordinator who work onsite to provide ongoing support services.

Throughout 2013, program participants coordinated events and activities in their respective buildings, including movie nights, field trips, a book club, and a recovery support group.

In 2013, participants were between the ages of 21 and 59 with an average age of 45. 92% suffered from mental illness and 65% struggled with chemical dependency.

OVERNIGHT SHELTER & RAPID REHOUSING

OVERNIGHT SHELTER

Simpson Housing Services' overnight shelter is dedicated to providing a safe, dignified place for men and women experiencing homelessness. Every night of the year, 66 guests receive a bed, three meals, a shower, laundry, access to health care, and advocacy as they search for a permanent home.

Of the men who stayed with us in 2013, 48% reported a mental illness and 62% reported alcohol or drug dependency. 26% had a physical disability. Of the women who stayed with us in 2013, 40% were victims of domestic abuse and 27% had a physical disability. Though we are proud to have provided beds to nearly 1,000 people in 2013, we had to turn away 1,739 due to lack of space.



RAPID REHOUSING

Our rapid rehousing program helps shelter guests with fewer barriers to housing stability move quickly from shelter into stable housing. Participants work with an advocate to find affordable housing and receive assistance to help them make the transition successfully. In 2013, the average rapid rehousing participant was 45 years old and had been homeless for 6 months before joining the program. 55% have a physical

disability and 42% reported having a mental illness.

YOUR IMPACT

MERCEDES



At just 26 years old, Mercedes has a lot of life experience. As a single parent with two young girls, she was living in shelter for over a year before moving into Simpson Housing Services' family housing program. Although shelter life was stressful, she considers herself lucky to have gotten in, as all local shelters were full to capacity.

For Mercedes, one of the most difficult things about being homeless was dealing with ongoing depression and self-esteem issues. She says that her self-esteem has

gotten a big boost since joining Simpson. "They show you that you can provide for your kids, that you can give them stable housing and love. Most importantly love."

She is working hard to ensure that her children grow up happy, healthy and educated. One of her first goals upon joining Simpson was to enroll her girls in a highly rated early learning program. She is also working towards getting her GED and a college degree, but being a single parent can make these goals harder to achieve. "When I get a car, finish school, get my GED and go to college, then me and my girls can build a better future. But having two kids, it's hard to do all that."

Mercedes is using the resources available at Simpson to the fullest, and knows that her current situation is only temporary. "I don't want to live here for the rest of my life. But this is a step, and it's stable housing for my kids. I'm living here to better myself."

Not only has her time at Simpson helped build her self-esteem, but it has also given her the opportunity to build basic skills like budgeting, cooking and parenting. Her weekly meetings with her advocate have been invaluable, both in building upon her personal goals and helping her become a better parent. "To have someone who cares about you and checks in with you, who wouldn't want that?"

YOUR IMPACT

COLLEEN



When Colleen was a child, she rarely had a stable place to call home. She struggled with schizophrenia while dealing with her father's alcohol addiction and abuse. Colleen also began abusing alcohol when she lost her husband in her early 20's.

When a violent crime left her with severe head trauma and nerve damage, she was no longer able to maintain

her own apartment. "It got to the point where I just couldn't live anymore. All of a sudden it was like I forgot how to talk and write," she explains. She became homeless, staying in local shelters and in the Hennepin County Medical Center psychiatric ward.

In June of 2013, Colleen was accepted into Simpson Housing Services' new opportunity housing partnership with Aeon and Spectrum Mental Health. She is now living in an efficiency apartment in downtown Minneapolis and is receiving the support she needs to be happy and healthy. "Everything I need is right here. I can get to everything. I can get to all my appointments, I can get my medication, I can participate in the community."

Colleen hosts art classes for other residents in her apartment complex and participates in a poetry club and cooking club. She is also proud to have celebrated a full year of sobriety this January. "If you really want to get yourself better and do something for yourself, this is the place to start."



VOLUNTEERS & DONORS

Simpson Housing Services is grateful for the incredible work of our many volunteers. We have over 2,000 active volunteers at any given time, including individuals and groups from local faith communities, corporations and schools. Last year, volunteers shared enough hours to equal 16 full-time employees!

Volunteers provided weekly tutoring for the children in our Soar program, served meals and stayed overnight at our shelter, provided holiday and birthday gifts for families, and provided fun activities at our program celebrations.

In 2013, Simpson Housing Services received a record \$276,909 worth of in-kind donations. Items ranged from t-shirts and toiletries to backpacks and school supplies. In-kind support not only helps offset the cost of running our programs, but provides the people we serve with necessities they might not otherwise have access to. 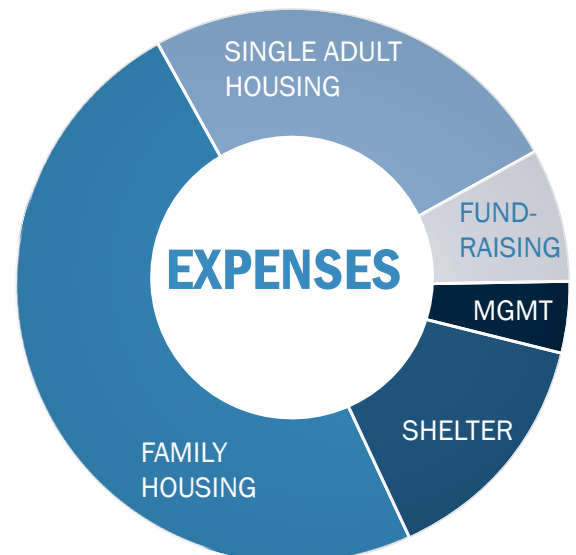
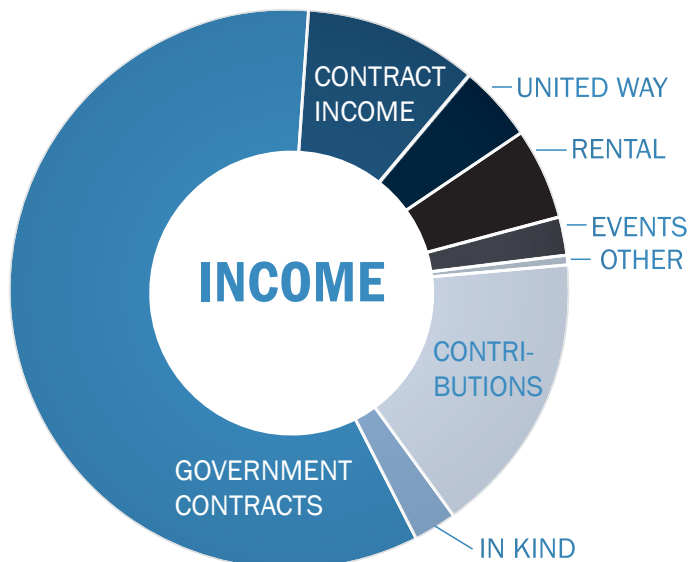
